Administrative History

The British Columbia Union Catalogue (BCUC) was a province-wide bibliographic database of library collections, representing both post-secondary and public libraries. First proposed in a series of reports in the early 1970s, it was established in 1977 and funded by the B.C. Ministry of Education. Participating libraries entered their catalogue records into a machine-readable database that was used to both generate local catalogues and produce a single union catalogue of all their collections. It was then distributed throughout the province so that users could locate materials anywhere in the province and obtain them through interlibrary loan. BCUC initially included the library collections at UBC, SFU, and UVic, and then expanded to include provincial college libraries. Richmond Public Library was the first public library to join the network in 1978. Provincial funding was discontinued in 1983, before the project was completed.

Custodial History

Records were kept by former BCUC Director Paul E. Baldwin, and then stored at UBC Library. They were later maintained by Nadine Baldwin, who transferred them to the University Archives.

Scope and Content

Fonds consists of records documenting the origins and early history of the British Columbia Union Catalogue, and includes correspondence, reports, and publications. They are arranged primarily in chronological order.
