# Fonds Description

**Community Learning Initiative fonds.** – 2001-2010.

## **Administrative History**

The UBC Community Learning Initiative (UBC-CLI) was established in 2006 to develop curricular community-engaged learning opportunities. Its central principle was the importance of "community service learning" (CSL) – the University's *Trek 2010* strategic plan had set a goal of developing programmes that engage 10% of UBC students in CSL each year. Students worked in teams on short-term projects that both link to course content and also meet the goals of the participating organizations. Its work was made possible by a grant from the J.W. McConnell Family Foundation. UBC-CLI worked in parallel with the Learning Exchange, founded in 2000 to facilitate student volunteer opportunities in Vancouver's Downtown Eastside. There was a great deal of overlap between the two programmes, and they initially reported to the same Director, Margo Fryer. In 2011 CLI and the Learning Exchange were separated into two distinct units, each with its own director, with CLI reporting to the Vice-President, Students. In 2012 CLI re-organized and changed its name to the Centre for Community Engaged Learning.

## **Custodial History**

Records of the UBC Community Learning Initiative, along with records of the Learning Exchange, were kept in the offices of the Centre for Community Engaged Learning, until their transfer to the University Archives.

## **Scope and Content**

Fonds consists of records which document the history of the UBC Community Learning Initiative, and includes correspondence, reports, minutes, written notes, and published items. It is arranged in two series: Administration, and Programmes.

## **Notes**

Fonds consists of institutional records – access requests must be reviewed by the University's FOIPOP Coordinator.

Records were transferred from the Centre for Community Engaged Learning to the University Archives in August 2017.

There was a great deal of overlap between the functions and activities of the Community Learning Initiative and those of the Learning Exchange. They also had the same Director for several years; they shared office space; and their records were filed and stored together. This inter-relationship was reflected in the records when they came to the Archives. During their arrangement and description the records were separated so that two distinct fonds could be recognized. However, this was not an exact process, and it is likely that some records from the Learning Exchange are still mixed together with those of CLI, and vice versa.
