Biographical Sketch

John MacKenzie Norris (1925-2010) was born on March 3, 1925 in Kelowna, B.C. to Jean Mary Norris (née) Denovan and Thomas Grantham Norris. At the time of his birth, his father, T.G. Norris, was practicing as a lawyer in Kelowna and subsequently served as a judge on both the British Columbia Supreme Court and the British Columbia Court of Appeal. John Norris had an older sister and a younger brother, attended elementary schools in Kelowna and Vancouver, and graduated from Lord Byng Secondary School in Vancouver. He enlisted with the Royal Navy in 1943 and, after returning, attended UBC from 1946-1949 where he obtained both a Bachelor of Arts Degree (1948) and a Master of Arts Degree (1949). At UBC he met Barbara Violet Casey whom he married in 1947. They had one son, Thomas Norris. John Norris pursued additional graduate work at Northwestern University, obtaining his Ph.D. in 1955, and post-graduate studies at the London School of Economics.

In 1953, John Norris began teaching as an instructor within the Department of History at the University of British Columbia and in 1964 became a Professor of the Department of History. He published five books and numerous articles in the areas of administrative, economic and demographic history. During the 1970s, he began to change his academic focus towards the history of medicine and over the next few decades he specialized in the study of the history of various diseases, including plague, cholera, and scurvy.

In 1980, John Norris was appointed Professor and Director of the Division of the History of Medicine and Science at UBC. He continued to serve in this role until his retirement early in 1990 when he was extended the title of Professor Emeritus in the History of Medicine. He continued to teach on a part-time basis until at least 2004.

Norris served on many boards and committees, including acting as the Chair of the Osler Medal Committee of the American Association for the History of Medicine (1978-1979); as Chair of the Programme Committee of the Canadian Society for the History of Medicine (1983); and as the Chair of the Grants Committee of the Hannah Institute for the History of Medicine (1980). At UBC, he served in such capacities as Chairman, University Curriculum Committee, UBC (1968-1974); as a Member of the University Senate (1964-1974); and as Chairman of the University Grievance Committee (1968-1969). He held an American Council of Learned Societies Graduate Fellowship, 1951-3,

a Nuffield Commonwealth Fellowship, 1961-1962, a Canada Council Senior Fellowship, 1967-1968; and a Killam Senior Research Scholarship, from 1975-1976.

John Norris was an active member in politics, first in the C.C.F., and subsequently of the N.D.P. In 1963, he unsuccessfully ran to be N.D.P. representative for Vancouver Centre during the British Columbia Provincial election.

John Norris died on May 2, 2010. At the time of his death, he was working on a history of cholera.

Scope and Content

Fonds consists of the personal papers of John Norris, including family papers, correspondence of both a personal and professional nature, notes of academic articles, lecture and class notes, as well as several photographs of Norris and his family. Fonds has been organized into seven series: Correspondence series; Family series; Political Career series; Hannah Institute series, Research Materials and Publications series; Teaching series; and Photographs series. Materials are arranged in alphabetical order unless otherwise indicated.

Notes

Thomas Norris, son of John Norris, transferred the bulk of these documents to the UBC Archives in 2014. File 2-7a was found in Woodward Biomedical Library and transferred to the Archives in 2018.

Note that RBSC at UBC contains the papers of Thomas G. Norris, the father of John Norris.

Series Descriptions

Correspondence series. – 1964-2005.

37 cm of textual records.

Series consists of correspondence sent to and received from John Norris.

Family series. – 1925-1990.

7.5 cm of textual documents.

Series consists of personal and family documentation such as birth and marriage certificates, transcripts, copies of articles and some collected newspaper reports.

Political Career series. – 1963.

20.0 cm of textual documents.

Series consists of notes, speeches, scripts, newspaper clippings, and other documentation related to John Norris' candidacy for the Provincial Election in 1963.

Hannah Institute series. – 1982-1992.

10.5 cm of textual documents.

Series consists of correspondence, applications, and materials related to successive Practitioner-Historian workshops offered by Norris during his association with the Hannah Institute for the History of Medicine.

Research Materials and Publications series. – 1980-1993.

1.25 m of textual documents.

Series consists of notes taken in support of various publications, such as those on the British economy during the 1800s, cholera, and the plague. Series also consists of copies of a number of Norris' publications.

Note that many of the research notes are without dates; however, it can likely be reasonably inferred that the notes regarding cholera were made in support of his unpublished work on cholera that was remained unfinished at the time of his death in 2010.

Also note that some notes that might have influenced his publications have been included in the Teaching series as they were described as pertaining to lectures and conferences.

Teaching series. – 1963-2004.

1.34 m of textual records.

Series consists of notes for lectures and seminars given in various classes, continuing education, and conferences; course materials, papers from colleagues and students; and documentation related to Norris' role on various committees and boards within UBC and as the Director of the Department of the History of Medicine and Science.

Photographs series. – 1946-1987.

32 black & white negatives; various sizes. 16 black & white prints; various sizes.

Series consists mainly of photographs of John Norris and Barbara Norris and of other family members. A number of photographs relate to images used by Norris during lectures or in scholarly articles. Photographs are arranged in chronological order.
