Biographical Sketch

John Tait Montague was born in Halifax, Nova Scotia in 1920. After completing graduate work at the University of Western Ontario (1943), he went to the Institute of Industrial Relations at the University of Toronto where he received his M.A. (1947) and Ph.D. (1952). Montague worked in the Federal Dept. of Labour from 1948 to 1962. He came to UBC in 1962 as the first permanent director of the Institute of Industrial Relations and continued in this capacity until 1969. Montague also taught some labour economics courses at UBC.

Scope and Content

The fonds consists of copies of addresses, correspondence, subject files and economics course records generated between 1961 and 1968.
