## Administrative History

*Pacific Affairs* is an international quarterly journal featuring articles on the current political, economic, social, and diplomatic problems of Asia and the Pacific. It was originally published by the Institute of Pacific Relations from 1928 to 1960. After the Institute disbanded in 1960, IPR secretary-general William Holland came to the University of British Columbia to head the Department of Asian Studies, bringing with him many of the IPRs records. *Pacific Affairs* was revived in March 1961, published by the University and with Holland as editor. Since Hollands retirement in 1978, *Pacific Affairs* has been edited by Heath B. Chamberlain (1978-85), R. Stephen Milne (1985-88), Ian D. Slater (1988-2002), and Timothy Cheek (2002- ).

## Scope and Content

Fonds consists of correspondence, manuscripts, contracts, and reports. The records document the administration of *Pacific Affairs*, in particular the editorial functions, and are arranged in the following series: Editorial Files, Contracts, Correspondence, Subject Files and Production Files.

## Notes

Fonds consists of institutional records – access requests must be reviewed by the University's FOIPOP Coordinator.

Additional accruals were received in 2005, 2006 and 2012. Further accruals are expected.

## Series Descriptions

**Editorial Files series.** -- 1977-2016.

2.77 m of textual materials.

Series consists of manuscripts, correspondence between the writers and the editor of *Pacific Affairs*, and correspondence between the editor and the academic referees who review articles prior to publication. The records document the academic editorial process of submission, peer review, and revision.

Arranged by volume and issue number, and alphabetically by author within each issue.

**Contracts series.** -- 1989-1994.
