# Fonds Description

**Walter Sage fonds.** – 1855-1980; predominant 1976-1980.  
9.52 m of textual records and other materials.

## Biographical Sketch

Walter Noble Sage (1888-1963) was born in London, Ontario. He received degrees from the Universities of Toronto (BA, PhD) and Oxford (MA). After lecturing at Calgary College and Queen's University he came to the University of British Columbia in 1918. He was appointed head of the Department of History in 1932 and remained at the University until his retirement in 1953. He was elected to the UBC Senate first in 1939 and began in 1945 a period of eighteen years of continuous service.

Sage's interest in the history of his adopted province began early with an article entitled, "The Gold Colony of British Columbia" (1921). The interest became a scholar's passion, reflected in his fostering of regional studies, creation of new courses and the steady output of books and articles that contributed to the historical knowledge of the Pacific Northwest. A striking feature of Sage's writing was the predominance of the biographical element, half of his twenty-six articles being devoted to such figures as Simon Fraser, Sir James Douglas, and the Spanish explorers. To him history, whether of the British Empire or of British Columbia, was a living study, absorbing for its revelation of human personality in action. Inevitably Sage rose to prominence in the historical associations and three times accepted a presidency, of the British Columbia Historical Association (1939), the Canadian Historical Association (1945) and of the American Historical Association (Pacific Coast Branch) in 1950. From 1944 he was a member of the Historic Sites and Monuments Board of Canada and in this field he persisted zealously until his death. Walter Sage did not restrict his horizon to history. A true humanist, in response to a request from the Social Science Research Council he prepared in 1944 a study of Graduate Training in the Arts in Canadian Universities, with Special Reference to Requirements for the M.A. and Ph.D. Degrees.

**Addresses and Writings series.** – 1914-1959.

Series consists of the text of addresses, lecture and course notes, manuscripts, typescripts, notes, essays, publications, book reviews, and a nearprint written by Walter N. Sage.
