# **Fonds Description**

**Women's Research Centre fonds.** – 1964-2000; 1976-1997 predominant. 3.57 m of textual records.

#### **Administrative History**

The Women's Research Centre (WRC) was founded in 1973 and emerged out of the BC Women's Studies Association. The Women's Research Centre was a feminist organization which was involved with research intended to promote action to change women's situations. The Centre maintained links with other women's organizations across Canada and responded to requests from women's groups and institutions regarding project and organizational development, government and institutional responses to women's issues, and public and professional education. The objective of the Women's Research Centre was to provide individual women and community-based women's groups with the information, analyses, and/or skills they needed in order to take action on issues of concern to them. The results of the research were used in workshops, seminars, and consultations and published in various pamphlets, reports, and books which were later distributed to women's groups and other interested organizations.

The Women's Research Centre was a registered, non-profit society with annually elected board of directors and a policy collective, composed of ten members of the Centre, who met monthly to make decisions on the overall policy and direction of the Centre and it's various projects. In addition, an advisory committee, composed of representatives from across Canada, met once a year to provide information and to review the Centre's plan from a national perspective. The Centre's work was carried out by research committees composed of volunteers. The volunteers were made up of women who were both interested in and had the ability to contribute to a particular research area. At least one member of the policy collective sat on each research committee. The Women's Research Centre was funded by an operation's grant from the Secretary of State Women's Program. In addition, the Centre also received grants or contracts from federal, provincial, and municipal departments and agencies as well as funding from private foundations for specific research projects. The Women's Research Centre disbanded in 2000.

#### **Custodial History**

Women's Research Centre was the sole custodian of the records.

#### **Scope and Content**

The Women's Research Centre fonds consists of eleven series. The records deal with various aspects of women's lives and focus on racial, class, and gendered issues such as pay equity, women in the labour force, sexual harassment, immigration and the gendered effects of cultural transition, isolation, women's health and the Tobacco Industry, wife battering, sexual assault, and the strengths and weaknesses of women's shelters, women and the law, political responses to women's situation, and the development of strategies for changing women's lives. In addition, the Women's Research Centre fonds contains administrative records of the organization. Multiplemedia records were created and used by the Women's Research Centre in the course of their research such as textual records, canvass banners, publications, maps, newspapers and newspaper clippings. Records created and used by the Women's Research Centre include the Women's Research Centre and BC Women's Studies Association constitution and mission statement, contracts, grant applications, project proposals, various research guides, surveys, statistics, various outlines, budgets, address lists, handwritten and typed notes, correspondence, facsimiles, discussion papers, extensive interdisciplinary manuscripts and abstracts created by members of the BC Women's Studies Association, extensive questionnaires and interview transcripts, drafts, reports, agendas, memos, briefs, meeting minutes, bulletins, press releases, various financial materials such as bills, receipts, expense claim forms, cheque stubbs, invoices, and income and expense sheets, workshop registration and evaluation forms, membership application forms, newspapers, pamphlets, brochures, newsletters, articles, books, log books, bibliographies, purchase orders, literature reviews, and maps.

File contains two newspaper clippings (1980s); a catalogue of Women's Research Centre publications; a report on women and immigration; a Women's Research Centre brochure detailing their organizational structure, mission statement, and mandate; an invitation to an open house (1990s); a sixpage report written by Women's Research Centre member Dorothy E. Smith on *Women and Psychiatry*; a letter addressed to the Honorable Tom Waterland concerning Bill 14 Forestry Act on the subject of logging (1978); a letter addressed to the Honorable Senator H.A. Olsen written on behalf of Yukon Council Status of Women (1978); a letter addressed to Mary McDougall in the form of a written submission formally requesting that a hearing be established concerning the Alaska Highway Gas Pipeline; publications; an single-page article written by Rosemary Brown on Family Violence (1991); and an article concerning the closing of daycare centers (1981).

Information pertaining to Women's Research Centre records may be found in the *Community Organization Directory -* Women's Research Centre association file, at the Vancouver Public Library.

The Administrative History has been extracted, in part, from a Vancouver Public Library Administrative History of the organization as well as from information found in a Women's Research Centre brochure outlining the organization's history, organizational structure, mission statement, and mandate. The brochure is located at the Vancouver Public Library. The BC Women's Studies Association is regarded as the "foremother" of the Women's Research Centre and thus, their records have been included in the Women's Research Centre fonds. The BC Women's Studies Association has records dating back to 1964, although the Women's Research Centre was not established until 1973. Source of title was supplied by the Women's Research Centre.

# **Series Descriptions**

**Battered Women and Their Children Series.** – 1975-1985 ; 1979-1982 predominant. 71 cm of textual records.

Series consists of a complete draft of the report entitled: Battered and Blamed: A Report on Wife Assault from the Perspective of Battered Women, co-authored by the Women's Research Center and the Vancouver Transition House in November, 1980. The report is based on a combination of case studies and surveys. At Vancouver Transition House and Munroe House, a second-stage housing facility and subsidiary of the YWCA, a Christian-based organization that provided financial resources and administrative support to Munroe House, women were interviewed, individually, and asked to fill out questionnaires on themselves, their spouses, and their children in an effort to construct a profile of battered women and their experiences. Transcripts of the women's responses were recorded in writing and included as permanent record. Interviews were conducted over the telephone and in-person. The goal of the study was to gather information on wife battering from the perspective of battered women. The Women's Research Centre, however, also looked at how women's shelters assisted battered women, once they reached a transition house, by conducting a series of interviews with the staff members who ran them. Additionally, the Women's Research Centre examined the responses of various levels of Government, Social Services, private-practice physicians, hospitals, out-patient units, school programs, clinical nurses, community care teams, obstetrical nurses, pre-natal teachers, and clinical psychologists to the issue of battered women and their children. The report examined the importance of using case studies as a methodology for establishing the context of wife assault. Furthermore, the report examined the circumstances behind wife battering, the consequences of wife battering, how to deal with wife assault, and concluded by offering a summary of the report, a conclusion of the findings, and future recommendations. Series includes original research proposal, budgets, four large flip-chart sheets of paper used in Women's Research Centre workshops, "Herstory of Transition House / Women's Research Centre Project," handwritten and typed notes, agendas, project outlines, statistics, charts, interview guides, research guides, self-evaluation guidelines, evaluation sheets, file sheets, interview transcripts, correspondence, draft reports, various reports concerning Transition House and Munroe House, Transition-House and Munroe-House residents, and Transition-House and Munroe-House staff, completed and blank questionnaires, project reviews, literature reviews, research project statement of purpose, hard copies of various presentations, pamphlets, articles, fact sheets, invoices, purchase orders, address lists, financial statements, meeting minutes, grant proposals and funding requests, memos, news reports, seminar registration forms and

attendance sheets, worksheets, various theoretical models, and a glossary of legal terminology.

Boxes 1 - 2

**Pay Equity Series.** – 1984-1993.

12 cm of textual records.

Series consists of extensive research materials created and used in the writing of the Women's Research Centre report entitled: Just Give Us the Money: A Discussion of Wage Discrimination and Pay Equity published in 1988. The report examines gender-, race-, and class-based wage discrimination in the Canadian public-sector workplace and offers strategies for legislating pay equity. The Women's Research Centre conducted extensive interviews with a variety of women in the labour force, held numerous workshops, and corresponded with various Trade Unions, all three levels of Government, and other women's organizations across Canada in an effort to gather a broad range of data on wage discrimination. Series consists of contracts, grant applications, project proposals, correspondence, drafts and completed copies of various reports, press releases, hardcopy presentations, handwritten and typed notes, photocopied and original newspaper clippings, newspapers, lists of recommendations, records pertaining to legislation on pay equity and wage discrimination, wage lists for various professions, articles, various outlines, discussion papers, fact sheets, business cards, brochures, draft interview guides, interview transcripts, "Just Wages: A Bulletin on Wage Discrimination and Pay Equity" newsletters and photocopies of newsletters, agendas, purchase orders for *Just* Give Us the Money: A Discussion of Wage Discrimination and Pay Equity, receipts and invoices, photocopied cheques, facsimiles, financial reports, requisition for payment forms, workplan revisions, and draft interview guides.

Box 3

**Women and Ethnicity (Non-Mudd Project) Series.** – 1976-1979 ; 1977-1978 predominant.

26 cm of textual records.

Series consists of records created and used by the Women's Research Centre on the subjects of immigrant women and wife assault, cultural and linguistic isolation, racism in society, education, the effects of applying monocultural models on the problems of immigrant women living in a multicultural society, and the development of strategies for establishing bilingual and bicultural models to better identify the problems and needs of women of different ethnicities. The Women's Research Centre interviewed workers at Vancouver Transition House, Powell House, "A Woman's Place," Cedar

Cottage Neighborhood House and Mosaic. In addition, the Women's Research Centre conducted interviews in Portuguese, Hungarian, Greek, Chinese, and East Indian communities. Research into these various issues lead to the publication of several reports such as: "The Social Organization of Family Violence: An Ethnography of Immigrant Experience in Vancouver: A Report to the Non-Medical Use of Drugs Directorate, Health and Welfare Canada," published in 1975; "The Social Organization of Family Violence: An Ethnography of Immigrant Experience in Vancouver," published in [1978]; "Services for Immigrant Women: Report and Evaluation of a Series of Four Workshops Conducted in the Summer, 1977;" "Workshops on Services for Immigrant Women: Compilation of Worksheet Results," published in Summer 1977; and "Education in Industry: Industrial Problems in a Multicultural Society." The Women's Research Centre worked in consultation with umbrella organizations, committed to the promotion of multiculturalism, such as the Multicultural Society of British Columbia. Series consists of interview transcripts and questionnaires, workshop case studies, drafts and completed copies of various reports, correspondence, financial statements, cheque stubs, receipts, invoices, income and expense statements, budgets, job advertisements, address lists, grant applications for Non-Mudd project, Non-Mudd project contracts, research proposal, guidelines for Non-Mudd project, hand written and typed notes, requisitions for cheques, interview schedules, information sheets, workshop summaries and evaluation results, workshop outlines and agendas, final project report guidelines, application forms, payroll records, employee records, manuals, meeting minutes, briefs, newsletters, membership applications, resource lists, organizational charts, time log analyses, workshop statement of objectives and statement of purpose, published articles, microdata set description files, and discussion papers.

Boxes 3-4

Sexual Harassment Series. – 1978-1987.

42 cm of textual records.

Series consists of records created and used by the Women's Research Centre on the subject of sexual harassment in the workplace. The Women's Research Centre distributed questionnaires to employed women in an effort to identify the existence of sexual harassment in the workplace, and determine levels of sexual harassment, types of sexual harassment, frequency of sexual harassment, women's reactions to sexual harassment and the consequences of reporting such behavior. The research process involved working with Labour Unions, conducting interviews, and holding conferences. Series consists of questionnaires, correspondence, published booklets on Sexual Harassment, various reports, newsletters, newbriefs, advice sheets, press releases, *Human Rights Code of British Columbia*, communiqués, various articles, legal

documents, address lists, hand written and typed notes, agendas, sample research projects, graphs, photocopied and original newspaper clippings, conference registration forms, interview transcripts, Canadian Broadcast Corporation (CBC) radio transcripts, newspapers, various outlines, drafts and completed copies of various reports, fact sheets, stickers, and statistics.

Boxes 4-5

BC Women's Studies Association (BCWSA) Series. – 1964-1978; 1971-1978 predominant.

40 cm of textual records.

Series consists of records created and used by the BC Women's Studies Association, the "foremother" of the Women's Research Centre. Series consists, predominately, of interdisciplinary manuscripts written by BC Women Studies Association student members on various subjects specific to the interests of the Women's Research Centre. Such research topics include capitalism and society, marriage, state beauracracy, family violence, social relationships and community ideology, creation of a woman's centre, motherhood, suffrage, sexism, schools and society, women and education, and women's oppression. Many of the papers had been previously presented at conferences and seminars across Canada. Series consists of guide books for establishing a Women's Studies Programme, newsletters, memorandum, handwritten and typed notes, extensive numbers of manuscripts and abstracts from student members of the BC Women's Studies Association, the BC Women's Studies Association proposed act and constitution, proposed by-laws, Manpower and Immigration Guide to Applicants - Canada Works, correspondence, various guidelines, meeting minutes, mailing lists, receipts, booklets, press releases, BC Women's Studies Association membership applications, newspapers, questionnaires, handbooks, seminar announcements, news clippings, brochures, various drafts and completed copies of reports, project proposals, grant requests, television transcripts, television programs, course outlines, statistics, bibliographies, workshop outlines, educational material related to the British Columbia School Trustees Association (BCSTA), lists of recommended books, articles, magazines, purchase orders, requisitions for cheques, and cashed cheques.

Boxes 5-6

Patterns of Violence Series. – 1976-1999.

41 cm of textual records.

Series consists of records created and used by the Women's Research Centre in the process of researching patterns of violence against women and children. Series is

broken down into a number of small research projects that focus on various forms of violence against women and children. Series examines patterns of violence such as incest, sexual assault and date rape, wife assault, violence against women in society, pornography and prostitution, women's health and the tobacco industry, racism, and poverty. In the process of gathering data, the Women's Research Centre worked with organizations and groups such as Vancouver Incest and Sexual Assault Centre Society (VISACS), Women Against Violence Against Women (WAVAW), community sexual assault support centers for mothers of sexually abused children and adult survivors of sexual abuse, Family Services of Greater Vancouver, police liaisons, Women Police Liaison Committee, YWCA Crabtree Corner, Rape Crisis Centre, Northern Women Task Force, Feminist Centre for Action Research on Violence Against Women (FARVAW), Family Violence and Violence Against Women Centre, Canadian Research Institute for the Advancement of Women (CRIAW), and Family Support Institute (FSI). Series consists of claim forms, definitions of terms, financial statements, budgets, invoices, contracts, applications for contributions, memos, handwritten and typed notes, correspondence, address lists, project proposals, various outlines, project guides, development planning sheets, evaluation forms, questionnaires, various drafts and completed copies of reports, evaluation summaries, profile sheets and follow-up profile sheets, rules for conducting various groups dealing with sensitive issues, group outlines, log sheets, reviews, bulletins, mail, grant application forms, requisitions for cheques, research designs, interview transcripts, work plans, production checklists, workshop agendas, round table discussion questions, strategies for implementing institutional changes, literature reviews, interview guides, bibliographies, analysis guides, various explanatory models for understanding patterns of violence, meeting minutes, cheque stubbs, receipts, contribution agreements, blank and used cheques, account signature card, personal expense sheet, facsimiles, lists of objectives, appendixes, advertisements, workshop sign-up sheets, workshop participant feedback, information sheets, job postings, job descriptions, Women Against Violence Against Women and Family Support Institute mission statements, lobbying strategies, charts, resource materials and kits, discussion papers, drafts of action plans, list of data analysis categories, flip chart notes, checklists, and hard-copy presentations.

Boxes 6-7

Strategies for Change Series. – 1978-1992.

16 cm of textual records.

Series consist of records created and used by the Women's Research Centre in the process of developing strategies for change. The Women's Research Centre collected data on various women's experiences, and developed action plans and strategies for implementing social and legislative change designed to benefit women. The Women's

Research Centre worked with the Law Foundation of BC, the National Advisory Committee, the Port Alberni Friendship Centre, India Mahila Association, and Gold River Community Initiatives Society. In developing strategies for change, the Women's Research Centre held workshops, conducted surveys and interviews, and produced numerous reports. There was extensive correspondence between the Women's Research Centre and various levels of Government. Series consists of agendas, list of principles, meeting minutes, project proposals, articles, address lists, work-plan outlines, budgets and financial statements, correspondence, timelines for proposed strategies, strategies for implementing social and legislative change, workbooks, lists of references, typed and handwritten notes, project expenditures, publication lists, booklets, annual reports of the Law Foundation of BC, receipts, cheque stubbs, funding applications, invoices, phone bills, purchase orders, personal expense sheets, application form guides, questionnaires, India Mahila Association statement of purpose, framework for developing a strategy for change, photocopies of articles, guidelines for Women's Research Centre, travel expense claim forms, contracts, letters of agreement, photocopies of deposit slips, guidelines for facilitating workshops, workshop evaluation forms, facsimiles, Gold River organizational chart, calendars, reports, checklists, interview guides, Port Alberni Friendship Centre act, constitution, organizational chart, and history, surveys, feedback forms, newspapers, news releases, fact sheets, information sheets, and memos.

Boxes 7-8

**Pipeline Project Series.** – 1973-1985 ; 1979 predominant. 45 cm of textual records.

Series consist of records created and used by the Women's Research Centre in the process of researching the social and economic effects of the Alaska Highway Gas Pipeline on the lives of women and their families. The Women's Research Centre communicated with various groups and organizations such as the National Action Committee on the Status of Women, Royal Commission on the Economic Union and Development Prospects for Canada, Community Education consultants in Northern British Columbia, economic development think tanks, New Democratic Party (NDP) Action Groups, and the Ministry of Economic Development. The Women's Research Centre gathered data on Northern women's experiences and reactions to the Alaska Highway Gas Pipeline by conducting extensive interviews with women in Fort Nelson and Whitehorse. Series consists of correspondence, hard-copy presentations to the Ministry of Economic Development, memos, appendixes, handwritten and typed notes, extensive articles and photocopies of articles, Economic Development Conference evaluation forms, list of resolutions, workplans, extensive drafts and completed copies of various reports pertaining to urban expansion, the gendered division of labour,

women's role in economic development and the exclusion of women from full economic participation, a Northern perspective on health and social services for women, research into energy development and social institutions impacted by the construction of the Alaska Highway and Northern Gas Pipeline as experienced from the perspective of women in Northern communities, and the socio-economic effects of the Alaska Highway Gas Pipeline on the lives of women and their families. In addition, there are legal reports on forestry and logging, mailing lists, workshop summaries, grant proposals, copies of book chapters, newsletters, lists of publications, agendas, meeting minutes, list of farm tree license renewals, photocopies of *Bill 14 - the New Forest Act*, *Hansard vol. 4, no.20*, extensive material pertaining to the *New Forest Act*, maps, extensive Whitehorse and Fort Nelson interview transcripts, social impact assessments, Northern Pipeline Agency Act, conference announcements, newspapers, news clippings, research project proposal, briefs, interview guides, workshop issues list, analytical framework sheets, press releases, project evaluations, charts and spreadsheets, regulations, and project outlines.

Boxes 8-9

Women's Research Centre - Correspondence, Contracts, and Projects Series. – 1978-1997.

34 cm of textual records.

Series consists, predominately, of administrative records created and used by the Women's Research Centre. There is extensive administrative material reflecting the structure and day-to-day functions of the Women's Research Centre. The majority of the records consist of government and non-government correspondence, contracts for various research projects and future publications, a broad and extensive range of financial material, including grant proposals and requests, as well as detailed project proposals and project outlines. Series consists of records dealing with issues of wife assault, family violence, self-advocacy and the handicapped, strategies for change and action plans, women, labour and unions, various issues concerning women's health, human rights, education, legislation, as well as community services and activism projects. The Women's Research Centre interacted with various government and nongovernment groups and organizations such as the Family Violence Prevention Division Health and Welfare Canada, Department of the Secretary of State of Canada, BC Association for Community Living - Self Advocacy Caucus, Summer Institute for Union Women, BC Federation of Canadian Labour, National Action Committee on the Status of Women, Law Foundation of BC, and Disabled Women's Network (DAWN). Series consists of correspondence, contracts, Microboard project evaluations, Microboard reviews, various drafts and completed copies of reports, meeting minutes, Microboard resource guides, interview guides, agendas, round-table discussion guides, invoices,

various newsletters, definition of a Microboard and Microboard mission statement, outline of Microboard components, principles, functions and guidelines of Microboard, handwritten and typed notes, evaluation forms, facsimiles, list of Microboards, statement of philosophy concerning services to the handicapped, Women's Research Centre constitution, income and expense statements, grant application forms, appendixes, lists of publications, lists of Women's Research Centre Board of Directors, budgets, lists of Secretary of State programs, Secretary of State grant approval forms, address lists, cheque stubbs, financial statements, self-evaluation forms, self-evaluation guidelines, brochures, copies of The Voice and BC Association for Community Living News newsletters, and Caucus history of the BC Association for Community Living - Self Advocacy Caucus, an organization dedicated to promoting self advocacy for the mentally handicapped. Series also consists of publication announcements, articles, photocopied news articles, research proposal addressed to the Family Violence Prevention Division Health and Welfare Canada, Department of the Secretary of State of Canada - Women's Program funding request, various magazines, memorandum, receipts, cheque stubbs and photocopied cheque stubbs, booklets, brochures, newspapers, list of national social services organizations, requests for advance payment, published copy of National Welfare Grants Rules, log book, bulletins, program plans, Civil Rights definitions, bibliographies, hard-copy presentations, list of recommendations, discussion papers, photocopied cheques, work statements, worksheets, surveys, various models, statement of royalties, extensive photocopied material, and a list of terms of reference.

Boxes 9-10

Women's Research Centre & United Way - Research on Family Violence Series. – 1977-1994; 1977-1979 predominant.
7 cm of textual records.

Series consists of records created and used by the Women's Research Centre in the process of conducting research on family violence. The Women's Research Centre worked in cooperation with the United Way Task Force on Family Violence. Data for the project on Family Violence was collected at symposiums, conferences, group meetings, and workshops Series consists of memorandum, cheque stubs, various photocopied materials, invoices, contracts, various outlines, brochures, Symposium on Family Violence announcement, conference papers, address lists, registration forms, typed and handwritten notes, evaluation forms, schedules, media coverage, project analyses, extensive original and photocopied newspaper articles, various drafts and completed copies of reports, press releases, project proposals, grant applications, various agendas, budgets, correspondence, programme objectives, extensive meeting minutes, draft flyers, and various newsletters.

#### Women's Research Centre Publications Series. – 1974-1995.

23 cm of textual records.

Series consists of published and unpublished material created and used by the Women's Research Centre. The publications are the result of research conducted by the Women's Research Centre throughout the course of their existence as an organization. The Women's Research Centre is the author of all publications. Series consists of various pamphlets, brochures, extensive numbers of papers, action research kits, reports, briefs, published materials, and a large hand-painted canvass banner which reads: *Restore Funding for Feminist Research*.
