Bio/Admin Constructed on the Skeena River in 1873, the Inverness Cannery was purchased by J.H.

History: Todd and Son from the Turner, Berton Company.

Scope/Content: The fonds consists of the financial records and correspondence of Inverness Cannery. It includes vouchers, journals, ledgers, invoices, receipts, cash books and fish records. Correspondence and other data relating to the trap net licence situation and Sooke Harbour Fishing and Packing Company, Ltd. (1935-1937) is also included. Fonds also includes plans of the cannery and a CNR right-of-way.
