FEES FOR USE OF RBSC MATERIALS

Reproductions of RBSC and UA materials are subject to a user fee of \$40.00 per image when approved for commercial use in publishing, video production, self copy, exhibits, product presentations, interior design, advertising, or similar commercial use, including for-profit work done by consultants or commercial design firms on behalf of government agencies or non-profit institutions; a \$75.00 fee is charged for television use. Pre-payment is required. **Fees are for one-time and non-exclusive use and are in addition to any reproduction costs.**

CONDITIONS OF REPRODUCTION

1. Reproductions will be handled through the University of British Columbia Library, Rare Books & Special Collections (RBSC) or University Archives (UA).
2. Reproduction may be refused in cases of donor restriction, the physical condition of material, or copyright law.
3. If a copy negative must be made, the negative remains with Rare Books & Special Collections (RBSC) or University Archives (UA).
4. The applicant assumes full responsibility for any infringement of copyright and for publication rights of reproduced materials.
5. Reproductions may not be further duplicated for sale or for subsequent use without specific agreement and the payment of any applicable fees.
6. Unless authorized in writing by Rare Books & Special Collections or University Archives (UA) and noted in the credit line, images will not be shown with added colouring, superimposed or transposed, or altered or cropped in any way that significantly changes the meaning or context of the image, or compromises its authenticity as an historical document.

CREDIT LINE AND COPIES REQUIRED

1. An appropriate credit line must be given in all cases of publication, exhibition, presentation, or any other display of reproductions from Rare Books & Special Collections, University of British Columbia Library or University Archives; in the case of photographs, the photographer (if named) and the negative number must also appear.

Examples:

- University of British Columbia Library, Rare Books and Special Collections, Nowell photo, neg. # 1455
- University of British Columbia Library, Rare Books and Special Collections, [collection name, box and folder number].

2. **One copy of any publication that uses reproductions from Rare Books & Special Collections or University Archives shall be donated to the University of British Columbia Library.** This shall include books, brochures, advertising materials, periodical issues, exhibition catalogues, and videotape productions, but shall not include motion picture films.

INDEMNITY

The Applicant agrees to indemnify and hold harmless the University of British Columbia, its Board of Governors, officers, employees, agents, students and volunteers for all claims and damages including all legal fees and disbursements and other professional fees, howsoever arising, directly or indirectly, under the Agreement.
