Indigenous Communities Research Collection / Frank Tester (collector). – 1888-2000.

Collector's Biographical Sketch

Dr. Frank Tester was a professor in the School of Social Work at the University of British Columbia. His research and practice focus on community development to address what are often taken to be personal and mental health problems. He is interested in the structural origins of social issues and the policies and practices that address them. His work focuses on collaborative, and community development approaches to problems like young Inuit suicide, housing and living conditions, food security and the impacts – social, cultural and environmental – of resource development projects. The themes of social organizing and resistance through methods like participatory action research and popular education inform his work, as do critical theories dealing with economic, social and cultural issues. While much of his research and community work currently focuses on Inuit settlements in the Canadian Eastern Arctic, he has also worked in Tanzania, Mozambique, Vanuatu in the South Pacific and Nicaragua. He also has an ongoing interest in Indigenous and environmental issues.

Tester is a documentary filmmaker and recipient of two international awards: the Gustavus Myers Award for his contribution to human rights in North America, and the Erminie Wheeler-Voegelin Prize from the American Society for Ethnohistory, Cornell University, for *Tammarniit (Mistakes); Inuit relocation in the eastern Arctic, 1938-1962* (Vancouver, UBC Press, 1994), co-authored with Peter Kulchyski, Native Studies, University of Manitoba. In his career, he collected publications, records, and other materials documenting Indigenous environmental and political concerns, Indigenous child and family welfare issues, and media coverage of these and other issues.

The collection also incorporates materials collected by Glenn Drover, former Director of the School of Social Work (1983-90), who entrusted Tester. Drover was an accomplished scholar and a dedicated advocate for social justice in Canada and globally. He was recognized for his lifetime contributions to Canadian social work when the annual national social worker award was re-named as the Glenn Drover Award for Outstanding Service. He worked with the Cree in the North, with youth in New York City, with people in various countries of Africa and Asia, and various social welfare programs.

Scope and Content

The collection consists of material related to Dr. Tester's and Dr. Drover's research, mostly related to Canada and Canadian Indigenous issues, and including news from around the world. A large part of the fonds consists of newspaper clippings from the 1980s and 1990s, related to Canadian affairs and global issues. Also included are copies of British Columbia provincial statutes and regulations dealing primarily with Indigenous issues, reports, and other materials documenting Aboriginal communities' history in British Columbia and throughout Canada, focusing mainly on child welfare issues.

This series consists of all materials that Dr. Tester collected related to Aboriginal communities, comprising two series that Tester had labeled as “Aboriginal Affairs – Historical” and “Aboriginal History Documents.”
