

**Names:** **Burdon Sanderson, John, Sir, 1828-1905**

**Description:** Sir John Burdon Sanderson was a physician and leading figure in Britain opposing the Anti-Vivisection movement. The fonds consist of a complete set of vivisection licenses and two small notebooks.

#### **Part 1 Vivisection Licenses**

This is the complete set of his vivisection licenses, from 1876 to 1905 (the year of his death). Of the utmost rarity. The first license is numbered “1”, and is in fact the first license ever issued in Great Britain under the Act of 1876. They are signed in person by the various Home Secretaries, Viscount Cross (Home Secretary 1874), Vernon Harcourt, Henry Matthews, H.H. Asquith (later Prime Minister), etc.

There are 32 documents on 27 leaves. The earlier documents are handwritten, the later ones are typed; all are signed. The leaves are fastened together in chronological order with the most recent one at the front.

These are two small notebooks in the handwriting of Lady Ghetal (Herschel) Burdon-Sanderson (1852-1909), filled with what appear to be extracts of personal letters by her husband, Sir John Burdon-Sanderson, and herself, recopied in the course of her research for her life of Sir John. Book II has 120 leaves, Book III has 80 leaves.
